NEW FEE DISCLOSURES, EFFECTIVE APRIL 1, 2018

- The following actions will be assessed a \$28 Fee per instance: Loan payment, deposit, or debit items including check, debits, ACH, electronic or Visa, etc. that are <u>returned for non-sufficient</u> <u>funds</u>. Courtesy Pay (overdraft protection) instances. Stop Payment orders for checks or other items.
- After an account has been dormant, with no activity for 12 months, a \$5 monthly dormancy fee will be assessed. After 3 years any funds left will be escheated to the Washington State Unclaimed Property Department for a fee of \$75.00.
- Garnishment, levy, or legal action required on an account will be charged \$75.
- Special Research or Account Services: \$25 per hour (1-hour minimum).

International Fraud Protection:

Due to increased International Fraud, we have set new parameters on our debit cards for purchases outside the United States. Anytime you are leaving or making purchases outside the United States, let us know which countries your card will be used in, so we can correctly maintain your card while you travel or make purchases.
